Article 1 Introductory Provisions

The Dean of the Faculty of Chemical Technology (hereinafter referred to as "FChT") issues this Measure which specifies in detail the conditions for accessing support for the funding of publishing activities by academic and scientific staff of the FChT.

Article 2 Publishing Support

An annual allocation of CZK 1.5 million will be earmarked from the FChT budget to support publishing in the form of Open Access.

- 1) The support is intended for academic and scientific staff of the FChT.
- 2) The support is primarily designated for publications that cannot utilize funding from projects contributing to the creation of the publications.
- 3) The support is specifically intended for publications contributing to strengthening the excellence of the FChT in selected FORD sub-disciplines (1.4 Chemical sciences; 2.5 Materials engineering).
- 4) The decision to grant support rests with the FChT Executive Board.

Article 3 Conditions for Utilizing the Fund

- 1) The corresponding author must have an affiliation with the FChT UPCE.
- 2) The journal in which the publication will appear must be listed in the Directory of Open Access Journals ([Directory of Open Access Journals – DOAJ](#)).
- 3) The journal must be fully open (not a so-called hybrid Open Access journal).
- 4) The journal must be indexed in the Web of Science Core Collection database.
- 5) The journal must be ranked in at least one field in the first decile (D1) according to the AIS (Article Influence Score) metric in the FORD classification.
- 6) The publisher of the journal must not be MDPI.
- 7) The article must be published under a Creative Commons public license ([About CC Licenses - Creative Commons](#)).

Article 4
Mandatory Requirements for Requesting Financial Support

- 1) A statement from the editorial board confirming the acceptance of the article for publication.
- 2) Documentation of the editorial board's request for payment.
- 3) The title page of the accepted manuscript, including the names of the authors and their affiliations.
- 4) Documentation of approval for submitting the request from the head of the department/institute where the applicant is affiliated.

Article 5
Final Provision

- 1) This measure shall become effective on the day of the Dean's signature.
