Article 1 Introductory Provisions

This Dean's measure regulates the Rules for awarding medals and awards of the Faculty of Chemical Technology of the University of Pardubice (hereinafter referred to as "the faculty").

Article 2 Description of medals and awards awarded

1. The Dean awards the Medal of Merit, the Medal for Extraordinary Merit (hereinafter referred to as "Medal of Merit"), and the Memorial Medal of the Faculty of Chemical Technology of the University of Pardubice (hereinafter referred to as "the Memorial Medal") in accordance with the faculty statute, in particular for:
 - a) merits in the development of the faculty, its status and prestige in the Czech Republic and abroad,
 - b) significant activity/work at the faculty,
 - c) achievements related to the faculty focus.
2. The Dean awards the Honorary Recognition of the Faculty of Chemical Technology of the University of Pardubice (hereinafter referred to as "the Honorary Recognition") mainly for outstanding results in creative, educational, and other activities.
3. The Dean awards the Students' Prize of the Dean of the Faculty of Chemical Technology of the University of Pardubice (hereinafter referred to as "the Students' Prize") to bachelor's, follow-up master's and doctoral degree students as a recognition of outstanding results during their studies at the faculty.
4. The Medal of Merit is a higher-level award and it is awarded to individuals or legal entities for merits to the faculty in the areas specified in paragraph 1.
5. The Memorial Medal is a lower-level award and it is awarded to individuals or legal entities for activities in favour of the faculty specified in paragraph 1.

6. The Honorary Recognition is the lowest-level award and is awarded to individuals for activities specified in paragraph 2.

Article 3

Decision on awarding of medals and awards

1. The Dean makes a decision on awarding the Medal of Merit, Memorial Medal, or Honorary Recognition on the basis of a proposals submitted by:
 - a) the Academic Senate of the faculty,
 - b) the scientific board of the faculty,
 - d) a member of the Faculty Executive Board,
 - e) the head of the department or institute,
 - f) a member of the academic community of the university.
2. The Dean makes a decision on awarding the Students' Prize on the basis of a proposal made by:
 - a) the chairman of the Final State Examination Committee for students of bachelor's and follow-up master's degree programmes
 - b) the head of the department or institute for doctoral degree students.
3. The Dean may make a decision on awarding the medals, the Honorary Recognition and the Students' Prize on the basis of his own proposal.
4. Proposals for awarding the medals, the Honorary Recognition and the Students' Prize are discussed by the Dean in the Faculty Executive Board.

Article 4

Presentation of medals and awards

1. The medal is presented to the awardee in a ceremonial manner by the Dean or the Vice-Dean designated by the Dean. A certificate of awarding the faculty medal is handed over to the awardee at the same time.
2. The Honorary Recognition is presented to the awardee in a ceremonial manner by the Dean or the Vice-Dean designated by the Dean.
3. The Students' Prize of the Dean is presented to the awardee in a ceremonial manner, during the academic ceremony (Bachelor's, Master's, Doctoral graduation ceremony). The Students' Prize of the Dean is associated with a financial reward. The amount of the reward is determined by the Dean's Announcement for the calendar year.

Article 5

Records of medals awarded

1. The dean's office of the faculty keeps records of the medals awarded in a register according to serial numbers separately determined for each type of awarded medals.
2. One piece of each type of faculty medal is permanently deposited in the faculty archive.

Article 6
Final provisions

1. The faculty medal is not intended for sale and cannot be donated for collecting purposes.
2. The Dean's Measure No. 1/2017 Rules for awarding medals and awards of the Faculty of Chemical Technology is cancelled.
3. This measure becomes valid and effective on the date of the Dean's signature.
