As the COVID-19 pandemic still persists, hospitals and other healthcare facilities operations have been significantly restricted, I decided to change the period of general practice (begin and end dates) for students of the Faculty of Chemical Technology of the University of Pardubice.

Students of the bachelor's degree study programme B3912 Special Chemical and Biological Programmes, the master's degree study programme N0914P360001 Bioanalytical laboratory diagnostics in health care and the master's degree study programme N0512A130006 Analysis of biological materials can complete the general practice during the period  $1 \, \text{March} - 12 \, \text{September 2021}$ , if they fulfil the study requirements with respect to the study plan and schedule of the academic year 2020/2021.

The general practice in these study programmes is possible to be completed in an alternative way in case of termination of an already concluded contract of the regular practice by institution, or in case of refusing to conclude a contract of the regular practice by institution as follows:

- a) recognition of the completed practice on the basis of job responsibilities of students as
  a required practice for the particular study programme or corresponding field of study
  regardless of the place or performance of the job responsibility,
- b) volunteer activity (work) in healthcare and social services, firefighting units, organising services and organising emergency service during the academic year 2020/2021 in connection with COVID-19 infection and the duration of this work has to correspond with no more than half of the days of the required practice. The student is required to write up a report on the course of the volunteer activity.
- c) writing up a report on laboratory methods corresponding with the required practice specialization ranging from 7 to 14 pages per 1 week of the general practice.

The student is required to submit a confirmation from the institution where the practice was completed in case of termination of an already concluded contract of the regular practice by institution, or in case of refusing to conclude a contract of the regular practice by institution. If the framework agreement on practice is terminated, the student is exempted from the abovementioned obligation. The student is required to submit an officially valid document confirming an implementation of the practice and volunteering according to paragraphs a) and b) containing all the required information necessary for verifying the validity of the document submitted. These confirmations have to be submitted to the secretariat of the Department of

Biological and Biochemical Sciences in person or by post. The guarantor of the subject will recognize the student's general practice or allow to implement the practice according to paragraph c) of this measure, based on the submitted confirmations. An email notification of the guarantor's decision will be sent to the student.
