### **Article 1** **Introductory Provisions**

- (1) Module 1 “Quality of selected results” is one of the five modules for the assessment of research organizations according to the Methodology for Evaluating Research Organisations and RD&I Purpose-Tied Aid Programmes (referred to as the “M17+”).
- (2) The selection of the results of the Faculty of Chemical Technology (referred to as the “FChT”), University of Pardubice for the assessment under Module 1 is conducted on an annual basis.

### **Article 2** **Joint Provisions**

- (1) The results must meet the requirements of the M17+ for the respective year.
- (2) The results must be listed in the RII (Result Information Index).
- (3) The results must have at least one author or co-author from the FChT.
- (4) Any results that are jointly produced by multiple entities must have a clear contribution to the FChT.

### **Article 3** **Nomination of Non-Bibliometric Results for Assessment**

- (1) A person appointed by the Dean of the FChT shall prepare an overview of non-bibliometric results used by the FChT during the assessment period that meet the requirements of Module 1 and are eligible for the assessment procedure. The overview shall be submitted to the heads of departments, institutes, the Research Centre and the Joint Laboratory (referred to as the “departments”).

- (2) The heads of departments shall submit to the Dean the results to be presented for the assessment under Module 1.
- (3) All necessary documents shall be prepared by the heads of departments in cooperation with the authors of the results.

#### **Article 4**

##### **Nomination of Bibliometric Results for Assessment**

- (1) The heads of departments shall submit to the Dean the bibliometric results to be presented for the assessment under Module 1.
- (2) All necessary documents shall be prepared by the heads of departments in cooperation with the authors of the results.

#### **Article 5**

##### **Determination of the Final List of FChT Results for Assessment Under Module 1**

- (1) The Dean of the FChT shall go through the list of nominated non-bibliometric and bibliometric results of the FChT and shall decide on the selection of the results to be submitted for the assessment under Module 1.
- (2) The proposals shall be submitted to the responsible Vice-Rectors of the University of Pardubice.

#### **Article 6**

##### **Final Provisions**

- (1) This Directive shall come into force on the date of issue.
- (2) This Directive shall come into effect on the date of issue.
